## **Adr Exam Papers**

The exam itself is a real test – three papers totalling more than five hours over the course of a day (closer to seven hours for those who take the rail paper too). The questions in the exam are designed to test the candidate's knowledge of the regulations – in this case, the regulations contained in the annexes to the ADR Agreement.
