Becoming A Vocational Expert. Social Security uses Vocational Experts (VEs) to provide evidence at hearings before an administrative law judge (ALJ). VEs provide services for SSA under a BPA to provide expert witness services for the Office of Hearings Operations (OHO). As a VE, you will provide impartial expert opinion evidence that an ALJ considers when making a decision about disability.

To become a vocational expert, you will typically have to complete an educational program in mental health or human services and gain significant work experience in the areas of vocational or rehabilitation counseling. You must also achieve additional credentialing in the form of professional licensure and certification.
